Admissions process

1. Admissions team

A professional undergraduate selection team, working in close cooperation with the admissions tutor, will be responsible for the selection process for the Liberal Arts programme.

2. Application assessment methods

All UCAS forms are considered independently by members of the selection team.

All applicants will be contacted within 4 weeks of receipt of application, to establish contact and inform the applicant of the process to be followed.

The Faculty seeks to recruit those applicants, from whatever background, who show commitment to the Liberal Arts and whose interests seem to match those of the Faculty. We take into account the normal evidence of achievement (A levels, GCSEs, etc.) but we seek to identify potential as well as rewarding past performance. We are actively committed to ensuring that our assessment procedures are concerned only with academic suitability.

All applications are considered on an equal basis. Forms are not segregated by the type of educational institution attended.

All applications are allocated scores on the academic record and the personal statement/reference. The respective weightings ratio out of 100 (academic: personal statement) is 30:70%

Applicants are not discriminated against on the grounds of race, ethnicity, nationality, gender, sexuality, religion, disability, or age.

3. Interview or Visit Day

All applicants who have received offers will normally be invited to a Visit Day in the course of the academic year. This gives them a chance to see the city and the University, to ask questions about the teaching programmes and other aspects of student life in Bristol, and to meet informally with existing staff and students. While attendance at a Visit Day is strongly recommended, it is not obligatory and plays no role in the selection process; it is also recognised that not all applicants will be able to attend.

International applicants are in most cases treated in the same way as home applicants, except that we recognise that attendance at interview or a Visit Day may not be practicable.

4. Correspondence with applicants

All correspondence relating to an application's status will be sent by email.

All applicants should be contacted when we receive their application, to establish contact and inform the applicant of the process to be followed. Applicants will then be notified if their application has been successful or unsuccessful, or to inform them that their application has been assessed but that we will not be able to make a final decision until later in the cycle.

Applicants who receive an offer will receive an invitation to a visit day.

5. Deferred applications

Deferred entry applications are considered, but applicants are expected to explain their reasons for requesting deferred entry and to describe briefly in their personal statement how their 'gap' year might subsequently benefit their university career. Only a very limited number of offers may be made to applicants in this category in order to ensure fairness to those applying in the next admissions cycle. Preference may be given to those with a clear and relevant academic purpose or with significant health or personal issues. Offers for deferred entry may be at marginally higher grades than the typical offers for immediate year of entry.

We urge applicants to submit applications in the current admissions cycle wherever possible.

Criteria for assessing applicants

A-level General Studies are not considered towards offers or academic assessment.

2. Additional academic criteria

Individual applicants are normally expected to have actual or predicted A-level grades (or equivalent) at the required level or above. All candidates should offer 3 A-Levels (or equivalent) including two in subjects taught in the Faculty of Arts.

We take an applicant's record at GCSE into account, but there are no specific requirements, except GCSE English Language and Mathematics and we recognise that an applicant's academic abilities may improve significantly subsequent to GCSE. Credit is given to the best 8 subjects.

All Liberal Arts students pursue a subject pathway as part of their degree (minimum one-quarter of the credit points) and individual subjects may have additional specific criteria.

These include:

- for English pathway, A-level in English Literature or combined English Literature and Language
- for Music pathway, A-level in Music
- for French pathway, A-level in French
- for pathways in other languages an A-level in an ancient or modern language

3. Personal statement criteria

The personal statement is vital for providing clear indications of the applicant's suitability for the course. We are looking for evidence of:

- interest in and commitment to subjects taught in the Faculty of Arts;
- interest in links between these subjects and overarching themes of historical or contemporary relevance;
- relevant reading or research beyond the A level syllabus;
- clear thinking and understanding, problem solving and analytical skills, and creativity;
- grammatically correct, clearly structured, and stylishly written English;
- self-motivation and management;
- responses to opportunities and challenges faced.

7. Mature applicants

Mature applicants applying before five years have elapsed since taking A levels (or equivalent) will normally be treated as above. Where more than five years have elapsed, mature applicants will normally be expected to have successfully completed an Access course or vocational qualifications (e.g., GNVQ) and/ or employment history may in some instances be taken into account.

We will invite selected applicants to interview in order to assess their academic potential and ascertain their level of commitment to the academic study of the Liberal Arts. A decision will be made after the interview. These interviews typically take place in the New Year of the application cycle.

8. International applicants

International applicants will be subject to the criteria as detailed in this document.

Decisions are made irrespective of the status of the applicant. Satisfaction of academic and intellectual criteria overrides nationality, place of residence or fee status.

10. Contextual information

We take a holistic approach to all applications, ensuring that the educational and social context in which an applicant applies is taken into consideration, where supported by clear evidence that this may have adversely affected academic achievement. This may include time spent in Local Authority care, information about which is provided in the UCAS application. Such applications will have one grade lifted for their academic score: e.g. an AAB applicant will be awarded the same academic score as an AAA applicant. Applicants still need to satisfy specific subject requirements.

We also consider evidence of clear motivation to study. This may include attendance at a University summer school, a targeted Access Scheme (such as Access to Bristol or Realising Opportunities), or participation in other higher education outreach activities.

We do not take the following into consideration when making admissions decisions: the school type attended by an applicant, or whether an applicant's parent has any experience of higher education.

Offers

Typical offers for A-levels and other UK qualifications can be found in the Entry Data in the online [Undergraduate Prospectus](#). Offers to applicants with non-standard qualifications will be made equivalent to the published A-level offer.

We may make lower offers based on whether an applicant is deemed to have experienced educational disadvantage, as defined in section 7.5 of the [University's Admissions Principles and Procedures](#).

Other

1. Transfers

Incoming students will normally be expected to enter at the start of the next first year. Requests for transfers to our courses may be made from suitable applicants from other degree programmes within the University at the end of Year One.

Direct entry into Year 2 or 3 is not possible.

Acceptance is at the discretion of the Faculty and is subject to there being space available on the degree programme to which the applicant is applying.

2. Additional information

Liberal Arts is only available as a single honours degree. It cannot be studied as half of a joint honours degree.
