# Dissemination

Petra Baji's presentation "Up-to-date costs of hip fracture care in England and Wales identify substantial variation between hospitals; the REDUCE Study", generated interest at the Bone Research Society Annual Meeting in Manchester in July. In particular, her finding that hip fracture care costs the NHS significantly more in London and northeast England than in other regions prompted suggestions to share this data with the Royal Osteoporosis Society all-party Parliamentary committee.
